Bids are invited for the Construction works & Material Supply from the contractors registered in Construction Industry Development Authority (CIDA), under roads, buildings, services or valid Business Registration as required by the chairman, of the procurement committee of Ministry of Road Development, Transport Power & Energy and Housing & Construction, Central Province. Prospective Bids which are Rs. 5 million or over Rs. 5 million should be registered under the public contract Act No. 03 of 1987.

1. Above mentioned details shall be included in the requesting letter. Incomplete letters will be rejected with prior notification. Non-refundable tender fee shall be deposited to **account No. 158100110000022 at Peoples Bank** to the General Manager, Provincial Road Development Authority. Non-refundable tender fee of each work should be paid separately.
2. Requesting letters for bid documents through emails shall not be accepted after **01.00 p.m on 05.03.2026**. Considering the request, bid documents will be emailed to the bidders from **13.02.2026 to 4.00 pm on 05.03.2026** to the email address mentioned in the requesting letter.
3. Prebid meeting will be held on **20.02.2026 at 10.30 a.m.** at Provincial Road Development Authority, No. 09, Ehelepola Kumarihami Mawatha, Bogambara, Kandy.
4. The complete bid document which is sent by email should be printed in two copies by the bidder duly completed bid documents in duplicate should be put in separate envelopes indicating the contract number and the name or particular tender on the top left-hand corner of the each envelope mentioning original & duplicate and put in to sealed separate cover and should be sent to reach the address Chairman, Procurement Committee, Ministry of Road Development, Transport, Power & Energy and Housing Construction. No. 109, Yatinuwara Veediya, Kandy by registered post or deposited in the tender box on or **before 10.30 a.m.** on 06.03.2026.
5. Bids will be opened immediately after the closing time at the Ministry of Road Development, Transport, Power & Energy and Housing Construction at above address. Bidders or their authorized representatives will be allowed to join the bid opening.

The present progress and delays of planned progress of the works in hand under PRDA –CP especially considered and final decision shall be taken by procurement committee for awarding contract or not. As well the

final decision to award more than one contract for a single bidder shall be taken by the procurement committee. In addition, the contract work performed by the Provincial Road Development Authority for projects completed in 2025 by any institution or institutions registered under one individual's name will also be considered. As well, relevant Public Finance Circulars issued by Ministry of Finance related to procurement works also shall be considered.

All the supporting documents which are provided by the bidder with the bid document should be accurate & according to the instructions given in the bidding document. Bidder should be fully responsible for the accuracy of these supporting documents and incompleteness of these documents shall be a reason for rejection of bids. The Chairman of the procurement committee has all right to reject or not to award any tender or all tenders without giving any reasons and also has no any binding to accept the lowest bidder. The awarding time will be decided by the procurement committee.
